Cancellation/Refund Policy

The warranty period for bags and accessories is 30 calendar days from the date of purchase

In case of revealing defects during the established warranty period, the manufacturer (seller) acts in accordance with the applicable laws and regulations.

Complaints about defects will not be considered if the warranty period expires.

When contacting warranty issues, make sure to have:

Products in proper shape (clean, dry, odorless) and in their original packaging.

Invoice, sales receipt, receipt, or other document confirming the product's purchase.

The given Warranty Card:

The absence of the Warranty Card leaves the Contractor the right to refuse the Customer in products' warranty service.

The product warranty loses validity when there are the following defects:

Non-compliance with the seasonality timing when using seasonal products.

Non-compliance with the operating products' conditions (improper wearing, drying, etc.).

Products' transfer to third parties for repair.

Products' exposure to aggressive chemicals, liquids, high temperatures, and mechanical damage.

Subsidence and deformation of backs and toes, excluding defects resulting from mechanical damage or improper operation.
